## COMMERCIAL LOADING PERMIT APPLICATION

A commercial loading permit allows the permit holder to park at on-street metered spaces only or loading zone for a maximum 30 minute time period, while actively loading and unloading merchandise. **The permit is not valid in Municipal parking lots, in areas that have signs posted as "no parking", "no stopping", "no standing", or in fire lanes.** Commercial permits are valid for the calendar year. ## Commercial Loading/Unloading Permit - Rules and Regulations

1. This Commercial Loading/Unloading Permit is valid **ONLY** at on-street parking meters and not valid in Municipal Parking Lots.
2. This permit is only valid at on-street metered parking spaces for a maximum 30 minute time periods, while actively loading or unloading goods/merchandise.
3. This permit is only to be used while on **official company business**. Personal use of these permits may lead to a parking infraction or the cancellation of the permit.
4. **This permit is not valid in any areas that have signs posted restricting parking (i.e., fire lanes, "no stopping," "no standing," "no parking" zones, etc.).**
5. The City reserves the right to revoke any or all parking privileges at any time with written notice.
6. The permit must be placed on the rear view mirror in clear view at all times. Failure to do so will result in the issuance of a parking infraction in addition to the vehicle being towed at the owner's expense.
7. Duplication or tampering of the permit will result in immediate cancellation of parking privileges.
8. The permit issued may not be transferred to any vehicle other than those the permit was issued for. Violation will result in immediate cancellation of parking privileges. Any vehicle displaying an improper permit will be tagged and/or towed at the owner's expense.
9. The issuance of the Commercial Loading/Unloading Permit does not constitute a guarantee by the City of Niagara Falls that a parking space will always be available.
10. Permit holders must comply fully with and subject to the provisions of the City of Niagara Falls Parking and Traffic By-law No. 89-2000 or other City Parking By-laws and the Provincial Highway Traffic Act, as amended.
11. The issuance of a Commercial Loading/Unloading Permit does not grant any right or interest in the public right-of-way.
12. Parking Services Section of the Transportation Services must be notified in writing within two (2) weeks of a change of address or vehicle(s) for which a permit has been issued.
13. Should a vehicle, through failure to display said permit, be towed away, the City of Niagara Falls will not be responsible for costs or damages incurred, such costs will be the responsibility of the owner of such vehicle.
14. **This is NOT an "Overnight Parking Permit.** All vehicles must be removed off the street between 2:00 am and 6:00 am daily. Failure to do so will result in a parking infraction notice.
15. A \$10.00 fee will be charged for the issuance of a replacement Commercial Loading/Unloading Permit.
16. Permits are for the use of a metered parking space only. The City of Niagara Falls assumes no responsibility whatsoever for the loss or damage to the car or the contents however caused.
17. **Be advised that all outstanding parking tickets shall be paid prior to issuing any permits.**
