WATER AND PROPERTY TAX REBATE

How do I qualify for the \$102.00 Water Account Rebate and/or \$80.00 Property Tax Rebate?

- ✓ Must be a recipient of the Federal Guaranteed Income Supplement (GIS) or Ontario Disability & Support Program (ODSP).
- ✓ Must be a City of Niagara Falls Water Account Holder who is residing at the property.
- ✓ Must be a City of Niagara Falls Registered Property Owner who is residing at the property.

How do I Apply?

Applications are available from August 1st, 2022 to October 31st, 2022.

- Online at niagarafalls.ca
- In person at City Hall located at 4310 Queen Street, Niagara Falls ON.
- In person at The MacBain Community Centre at 7150 Montrose Road, Niagara Falls ON.

You can submit your application by email, in person, by drop box or mail. *Details provided on the application form.*

What do I need to provide?

- ✓ Proof of Address – Driver's License or other (ie: Utility bill other than water or property taxes).
- ✓ Proof of GIS for 2022 – Entitlement Letter for GIS from Service Canada.
- ✓ Proof of ODSP for 2022 – Confirmation Letter from ODSP Case Worker.

When and how will I receive my Rebate?

The rebate will be applied as a credit on your Water Account in the late fall of 2022 and will show as a credit under the adjustment line of your bill.

Note: One rebate per household. The GIS water and property tax rebate(s) and ODSP water and property tax rebate(s) cannot be combined.
