2. Motion to approve April 2023 Minutes

3. Confirmation of Committee Nominations for Chair/Co-Chair

- Staff summarized the nominations for positions of Committee Chair and Committee Co-Chair for the next Council Term (2023-2026).
- Marily Tian was selected as Chair and Sheila DeLuca was selected as Co-Chair.
- A motion from Cat Thigard and seconded by Councillor Campbell to approve the nominees for their respective positions.

- Staff provided the committee with an updated 2023 schedule of committee members who will provide a Land Acknowledgement at the beginning of each committee meeting.

- Staff advised that the consultant (Ms. Janelle Benjamin), from All Things Equitable will be meeting with the D&I Committee members and the members from the Anti-Racism Committee on June 26, 2023.
- The purpose of the meeting is to provide an executive summary of the work done to date which includes a thorough review of key Corporate Policies related to DEI as well recommendations made to enhance the policies.

7. Park Bench Donation from D&I Committee

- Staff updated the committee on their 2022 budget allotment as approved by Council. Both the D&I Committee and the Anti-Racism Committee are each allotted \$5000 per year. In December 2022, the committee had made a motion to purchase park benches (one orange in recognition of Truth and Reconciliation), and (one rainbow in recognition of Pride).
- Both benches have arrived and are currently in storage and ready for installment.
- A motion from Erden Ertorer and seconded by Cat Thagard that both benches be installed in and around the area of the new Exchange Facility.

- Staff will work with the Recreation, Culture and Facilities division to ensure the benches are installed in the coming months.
