## **ARENA RENTALS - RED ZONE**

In anticipation of the Niagara Region moving back to the Red Level of the provincial framework, the following changes will be implemented at the Gale Centre.

- Maximum of 10 participants in each rink
- Maximum 2 instructors in each rink
- Participants permitted 15 minutes prior to rental time and must exit within 15 minutes after
- 1 spectator per participant under the age of 18
- Gameplay and scrimmages are not permitted
- Rosters required ahead of time for all users and screening to take place for all
- Change rooms will be closed to all users
- Only participants, coaches, spectators that live in the Niagara Region are permitted at the Gale Centre
- Non prime ice - \$80.00 + tax, prime time ice - \$100.00 + tax for youth & adult
- All non-invoiced accounts must pay online - no exceptions

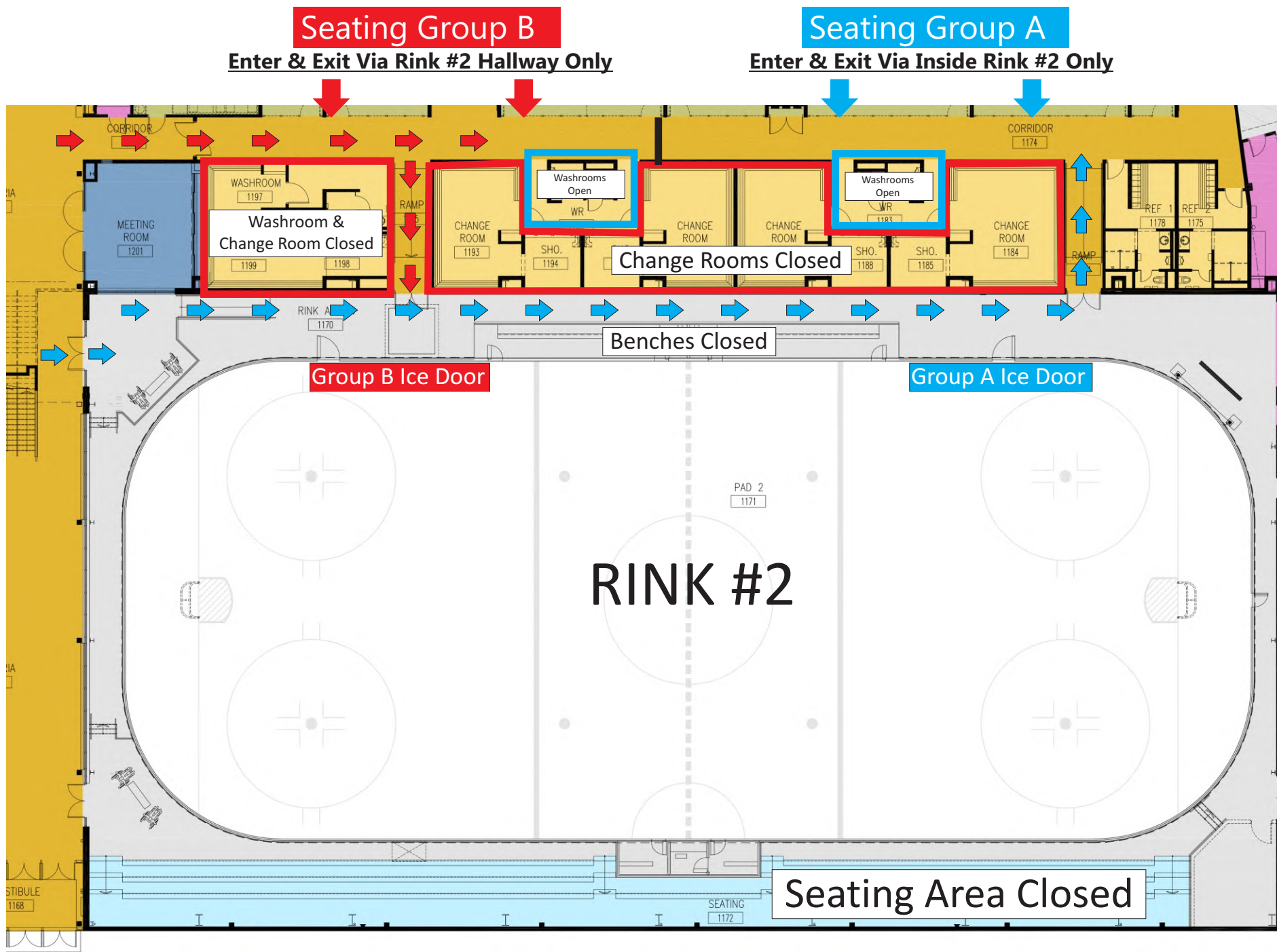


## ALL USERS MUST ENTER VIA FRONT DOORS TO BE SCREENED



# Gale Centre - Rink #2 (COVID 19)

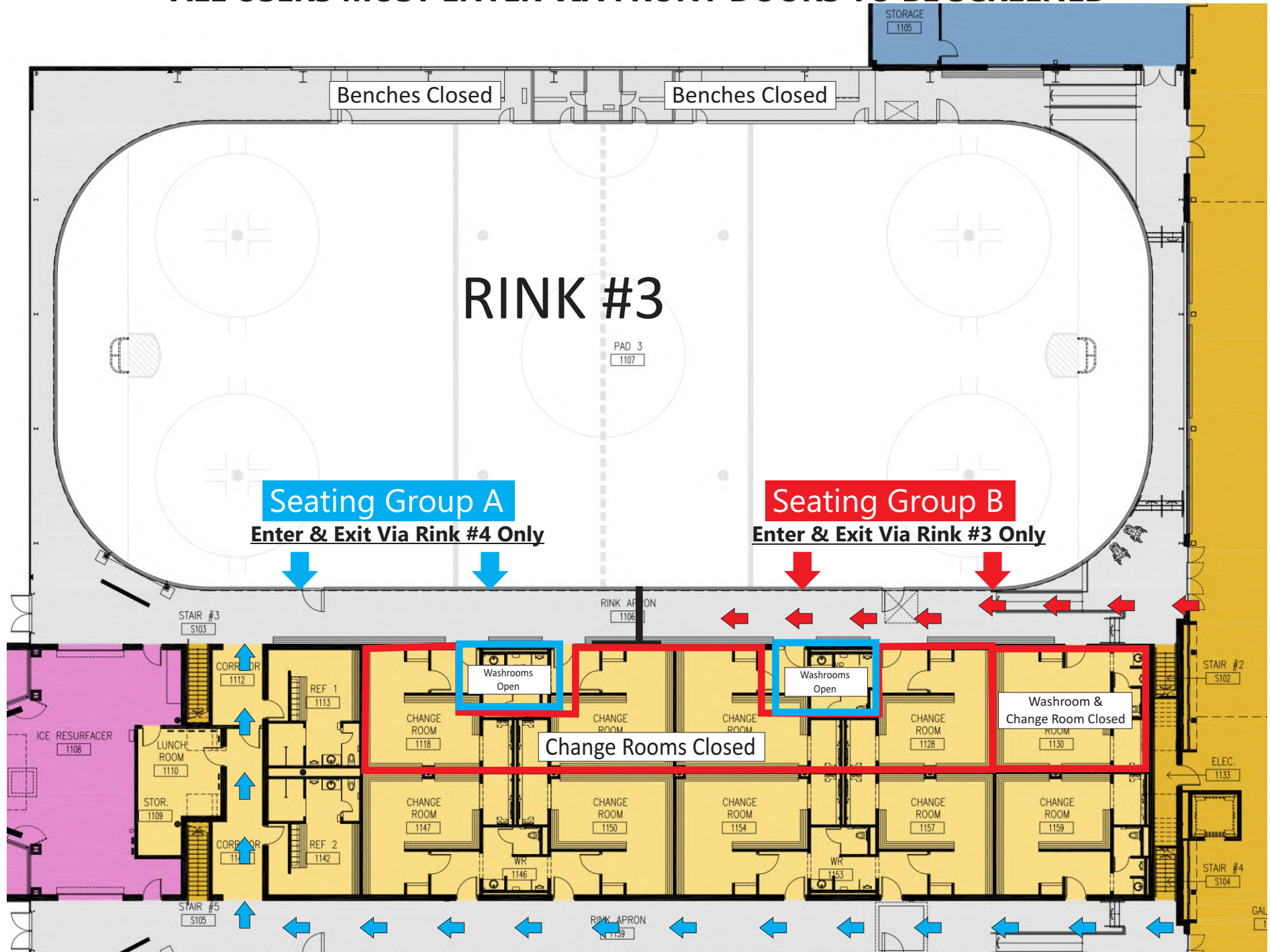

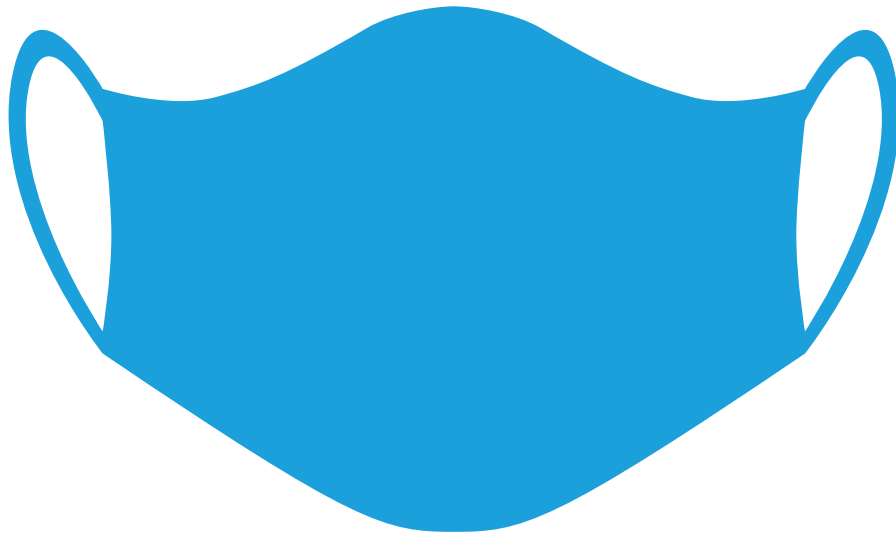
# Facility Entrance - March 2021



## Notes

- All users to enter via front entrance on Thorold Stone Road, start times staggered for separation
- Screening of all users (rosters required by all ahead of time)
- Areas to change in each rink separated by 2 groups (Group A & B)
- Entrances and exits identified by Group A & B must be followed by all
