THAT the City of Niagara Falls does not guarantee or warrant the toilet or its installation, the performance, freedom from defects, quality of workmanship or suitability of the toilet or any installation thereof for any purpose, or the suitability of the premises for installation. Further, the Applicant acknowledges and agrees to assume any and all costs of the installation or any alterations necessary for the proper installation of the toilet;

- 1. Once completed, all applications must be handed in to Cashiers (Finance Department) at City Hall, or at the customer service centre located at the MacBain Community Centre.
- 2. All applications <u>must</u> be accompanied by a **copy** of the original receipt from a **Canadian** retailer, including proof that the toilet(s) purchased are on the 2018 Approved EPA WaterSense labeled list. If the toilet Manufacturer, Make, and Model number are not listed on the receipt, a copy of this information as shown on either the Owner's manual or the packaging must be included with the application.
- 3. **Applications do not guarantee a rebate** as they are evaluated and processed on a first come first serve basis.
- 4. Rebates will only be credited to the water service account for the address where the toilet was installed. Proof of an active water service account at the subject address may be required (ie. a current water bill).
- 5. Applications will only be received for purchases within the current calendar year (2018).
- 6. The City of Niagara Falls actively encourages residents to purchase toilets at local retailers, however it is not mandatory to do so. The toilet(s) must be purchased in Canada.
