# PROPOSED AMENDMENT

A zoning by-law amendment application has been submitted to permit 12 townhouse dwelling units in 4 blocks, together with 6 accessory dwelling units. Schedule 1 shows the details of the proposal.

The land is currently zoned Residential Two (R2) in accordance with Zoning Bylaw No. 79-200 as amended. The applicant is requesting to place the townhouses under a site-specific Low-Density Group Multiple Dwellings R4 zone and add the use of accessory dwelling units. The proposal includes: a reduction of the minimum front yard depth, interior side yard width, rear yard depth, privacy yard and permit the encroachment of a roofed over onestorey covered porch in the interior side yard.
