Location: The subject property known as 7686 Dorchester Rd is located on the east side of Dorchester Road between Sunrise Court and Oldfield Road.

The applicant is proposing to extend/enlarge the legal non-conforming use specifically to increase the square footage of the existing detached shop by a proposed addition of 53.4 m². 








LEFT ELEVATION
