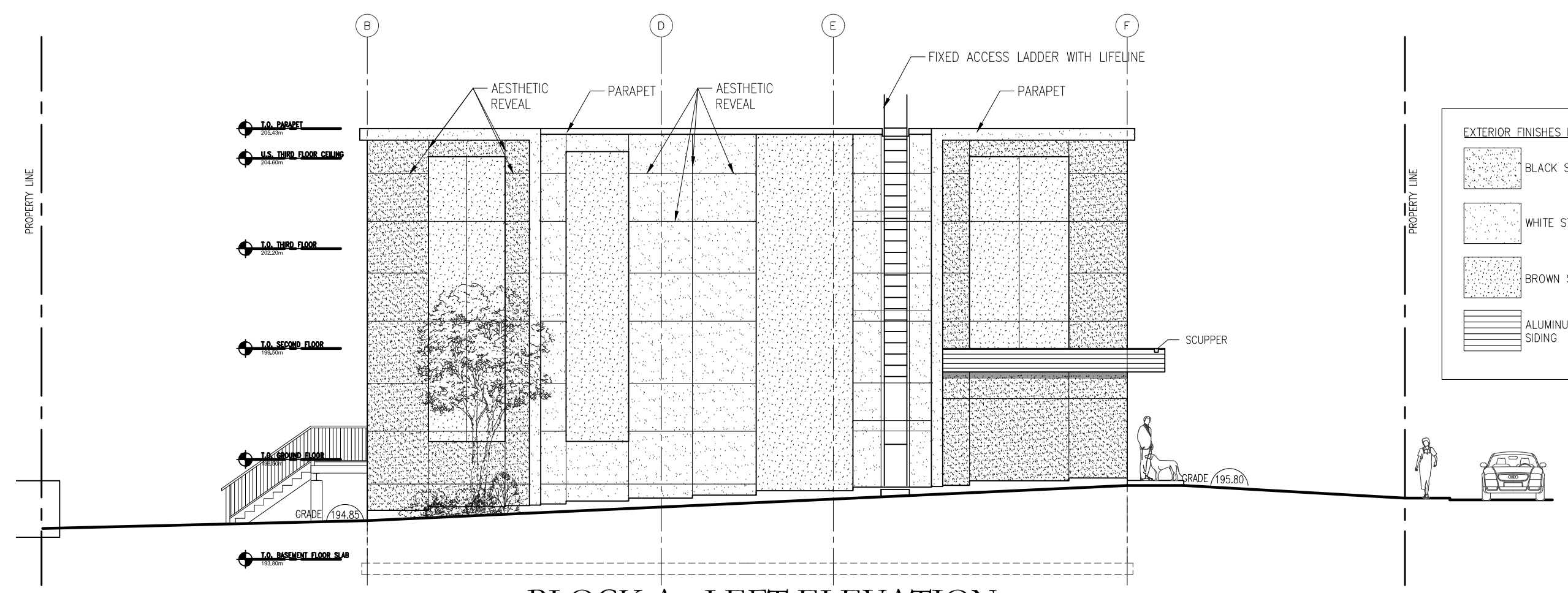
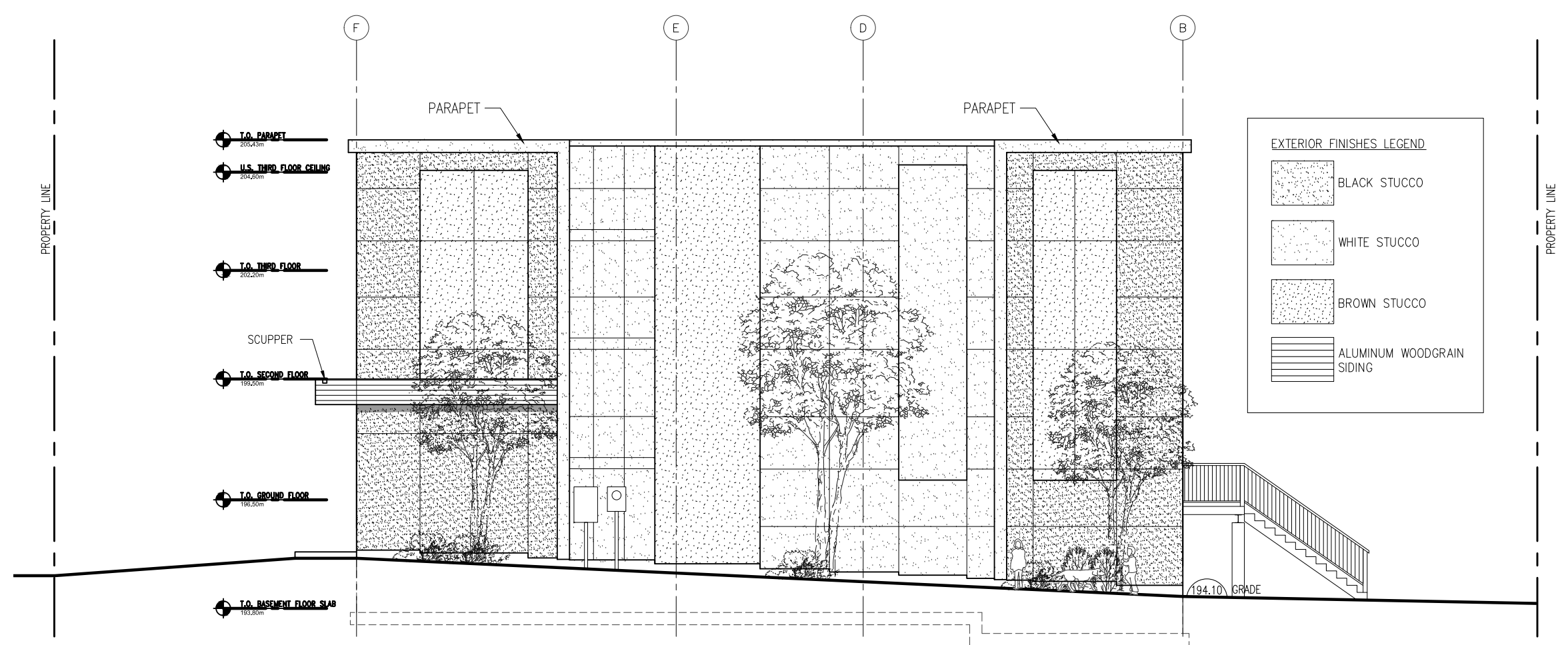




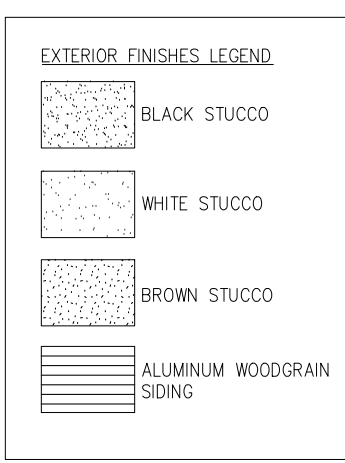
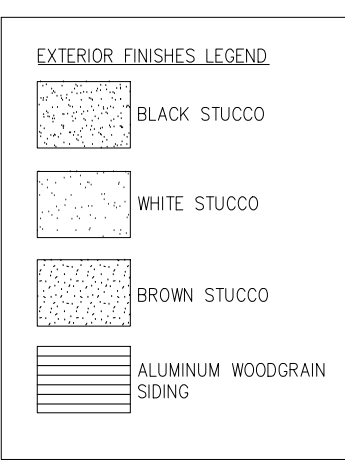
BLOCK A - FRONT ELEVATION



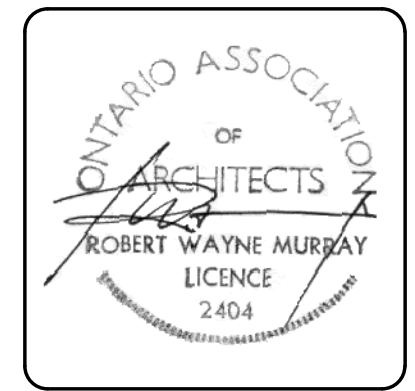
BLOCK A - LEFT ELEVATION

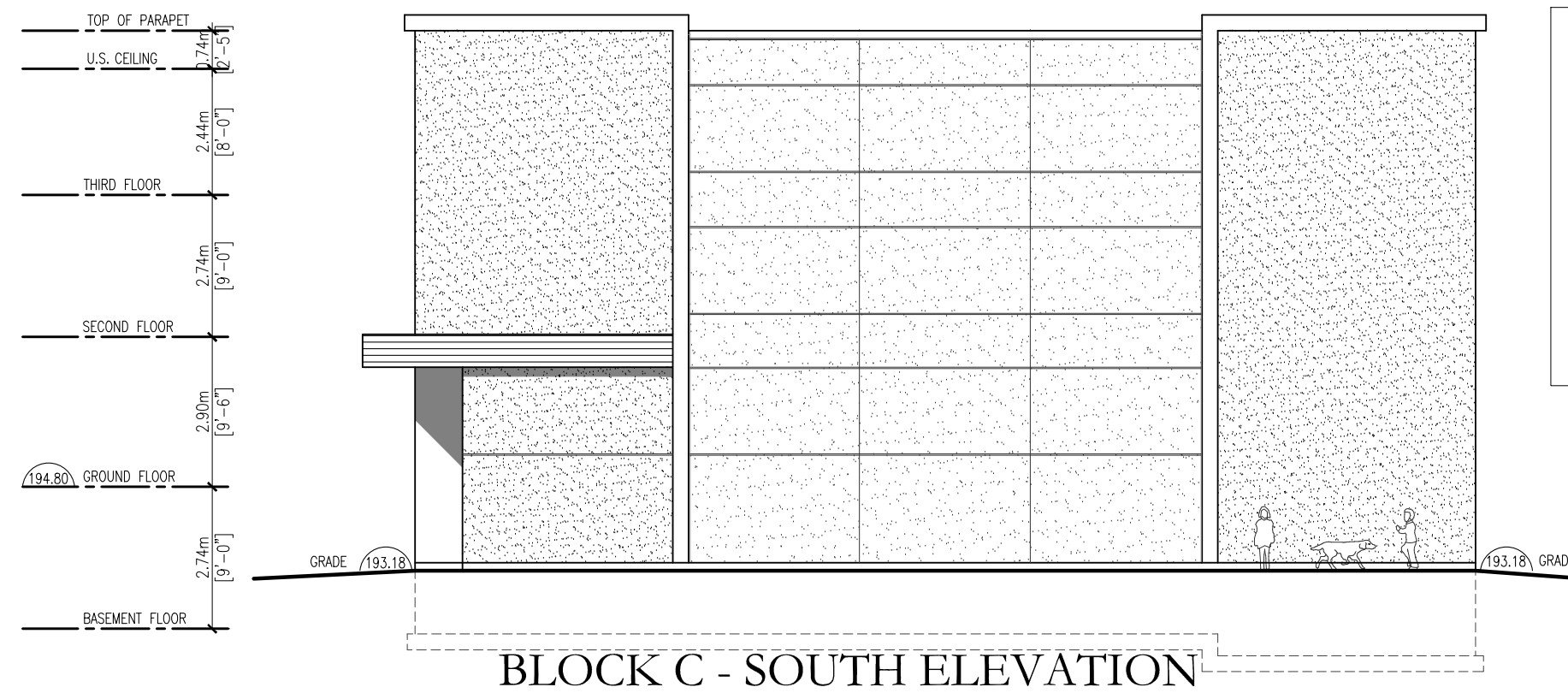

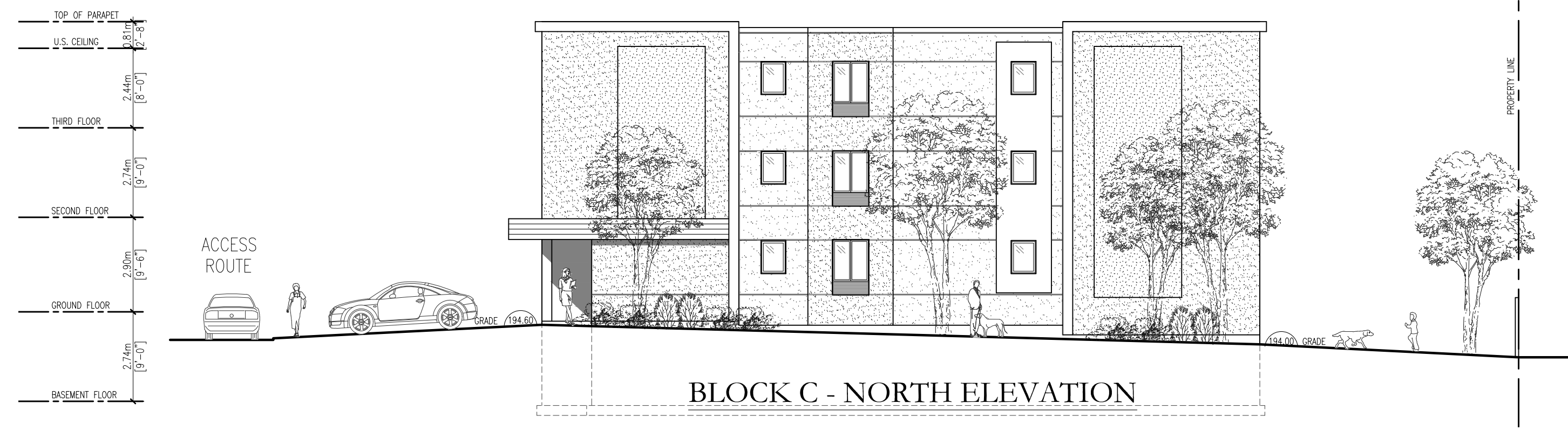

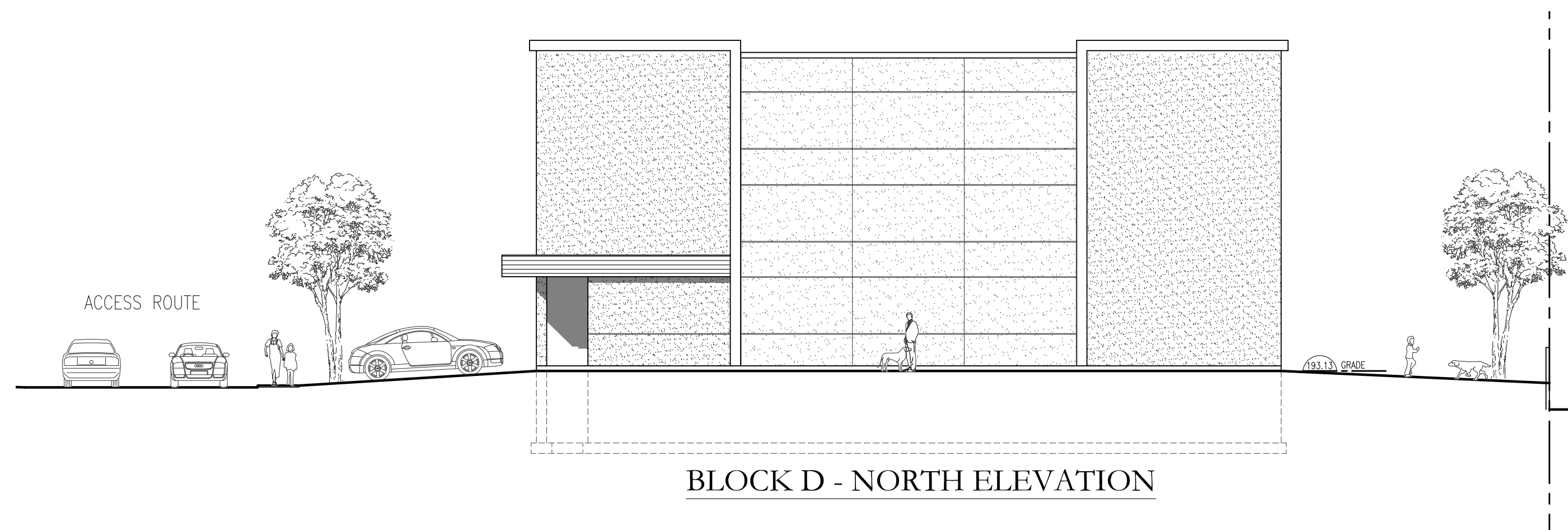

BLOCK D - EAST ELEVATION (FRONT ELEVATION)



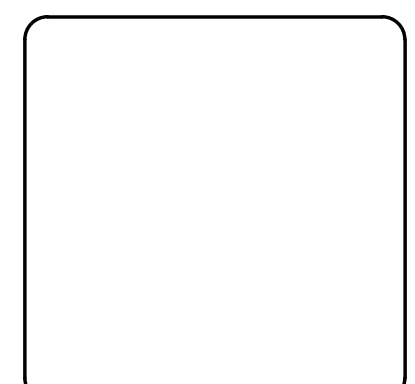
