

NOTICE OF INTENT TO PASS AN AMENDING BY-LAW TO REMOVE A HOLDING SYMBOL PURSUANT TO THE PROVISIONS OF THE PLANNING ACT

Removal of Holding Symbol from Lands Regulated by Zoning By-law No.79-200, as

TAKE NOTICE THAT THE GENERAL MANAGER OF PLANNING, BUILDING AND DEVELOPMENT OF THE Corporation of the City of Niagara Falls is considering the removal of a holding (H) symbol from Zoning By-law No. 2022-088, which was approved under section 34 of the Planning Act.

The subject land is 5687 Ferry Street. The property is zoned General Commercial GC(H)-1193 zone, in accordance with Zoning By-law No. 79-200, as amended by By-law No. 2023-062. The holding symbol was applied to prevent the development of the land until the landowner submitted an updated Functional Servicing Report and Third-Party Modelling was completed for sanitary services to the satisfaction of the City's Municipal Works Department. An updated Functional Servicing Report and Third-Party Modelling fees for sanitary services were submitted. Midtown Bowling (Niagara) Ltd. has requested the H symbol be removed to permit the mixed-use development of the property.
