Location: The subject property known as 4280 Fourth Avenue is located on the east side of Fourth Avenue, north of Hamilton Street.

The applicant is requesting the Committee of Adjustment to consider minor variances from provisions of Zoning By-law No 79-200, as amended, through a process permitted by Section 45(1) of the Planning Act (R.S.O. 1990, c.P.13).

Proposal: The applicant is proposing to construct 5 Stacked Townhouse dwellings containing 72 dwelling units on the subject lands.

The subject property is zoned Residential Apartment 5C

Density (R5C-1257) Zone in accordance with Zoning By-law No. 79-200 as amended by By-law No. 2024-092.
