# PROPOSED AMENDMENT

A zoning by-law amendment application has been submitted to rezone the subject property to a sitespecific Residential Apartment 5A (R5A) zone to permit an apartment building with 7 dwelling units. Schedule 1 shows the details of the proposal.

The land is zoned Deferred Tourist Commercial (DTC-97), in accordance with Zoning By-law No. 79-200 as amended by By-law No. 1985-155 and By-law No. 2012-060. The applicant is asking for relief from the by-law for the minimum lot area, minimum front yard depth, minimum interior side yard on the north side, and the minimum landscape open space area.
