Written comments are the preferred method of receiving public input and may be sent by mail or email. You can also provide oral input by joining the hearing in-person or electronically.

All interested persons are invited to attend this meeting to find out more about this application and offer comments. The public meeting is scheduled to take place on Tuesday September 26, 2023 at 4:00 pm, in Committee Room 2 at City Hall for the Committee of Adjustment to consider this application.

The applicant is requesting the Committee of Adjustment to consider minor variances from provisions of Zoning By-law No 79-200, as amended, through a process permitted by Section 45(1) of the Planning Act (R.S.O. 1990, c.P.13).

Proposal: The applicant is requesting a reduced interior side yard width for all lots within the draft approved Chippawa East subdivision. The subject property is zoned Residential Mixed Zone (R3-1162) in accordance with Zoning By-law No. 79-200, as amended by By-law No. 2022-006. The following variance has been requested:

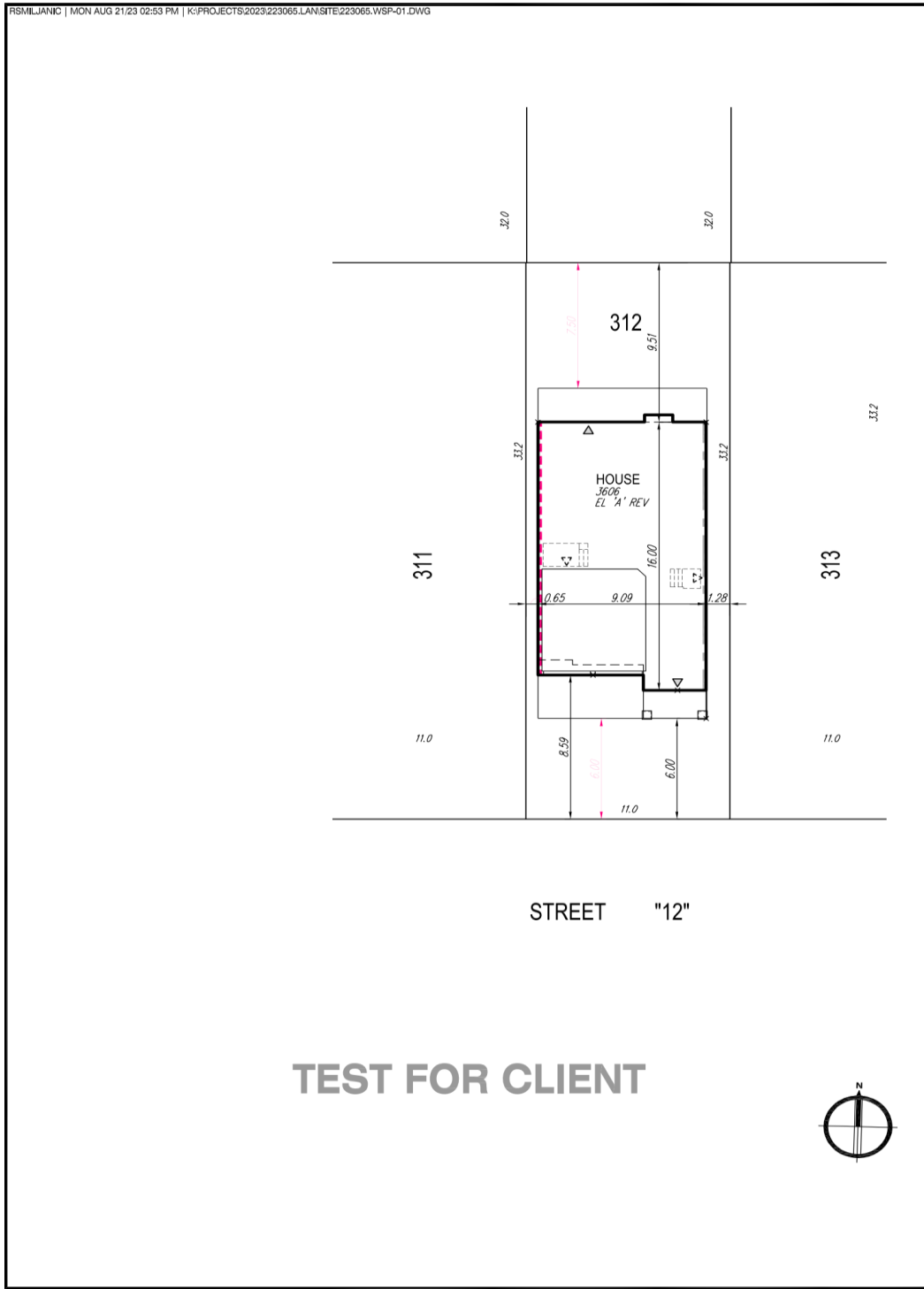
