Pursuant to Section 45 of the Planning Act, the Committee of Adjustment for the City of Niagara Falls invites you to participate in a public hearing to consider an application for minor variances and/or to forward written comments prior to the hearing. Written comments are the preferred method of receiving public input and may be sent by mail or email. You can also provide oral input by joining the hearing in-person or electronically.

All interested persons are invited to attend this meeting to find out more about this application and offer comments. The public meeting is scheduled to take place on Tuesday November 28, 2023 at 4:00 pm, in Committee Room 2 at City Hall for the Committee of Adjustment to consider this application.

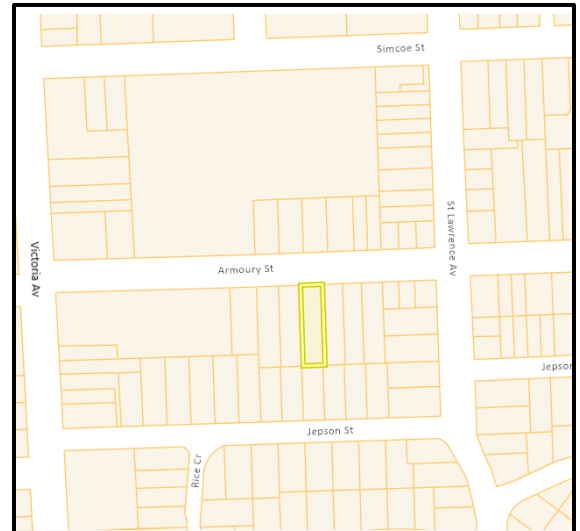

**Location:** The subject property known as 4708 Armoury Street is located between Victoria Avenue and St. Lawrence Avenue.

The applicant is requesting the Committee of Adjustment to consider minor variances from provisions of Zoning By-law No 79-200, as amended, through a process permitted by Section 45(1) of the Planning Act (R.S.O. 1990, c.P.13).

**Proposal:** The applicant has constructed an addition to the rear of the existing detached garage for storage purposes on the above noted property without a building permit. The subject property is zoned Residential Two (R2) Zone in accordance with Zoning By-law No. 79-200. The following variance is required:



By-law Section	By-law Requirement	Proposed	Extent of variance
4.13 (g) Total lot coverage for all accessory structures	No more than 15% of the lot area or 93 square metres	23.67% and 135.27 square metres	8.67% and 42.27 square metres

If a specified person or public body that files an appeal of a decision of the Committee of Adjustment for the City of Niagara Falls in respect of the proposed minor variance does not make written submissions to the Committee before it gives or refuses approval, the Ontario Land Tribunal may dismiss the appeal.

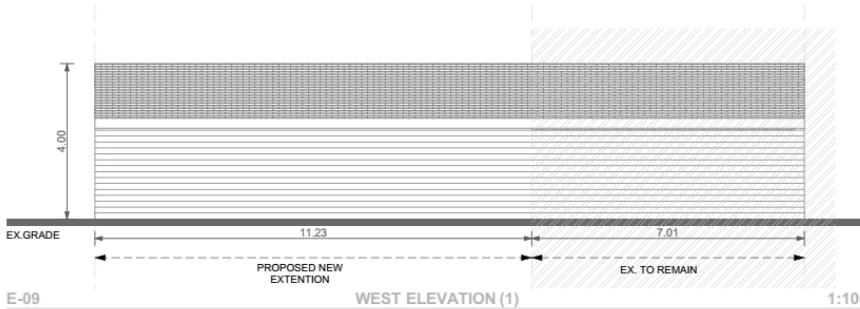
