Location: The subject property known as 4708 Armoury Street is located between Victoria Avenue and St. Lawrence Avenue.

The applicant is requesting the Committee of Adjustment to consider minor variances from provisions of Zoning By-law No 79-200, as amended, through a process permitted by Section 45(1) of the Planning Act (R.S.O. 1990, c.P.13).

Proposal: The applicant has constructed an addition to the rear of the existing detached garage for storage purposes on the above noted property without a building permit. The subject property is zoned Residential Two (R2) Zone in accordance with Zoning By-law No. 79-200. The following variance is required:


