Pursuant to Section 45 of the Planning Act, the Committee of Adjustment for the City of Niagara Falls invites you to participate in a public hearing to consider an application for minor variances and/or to forward written comments prior to the hearing. Written comments are the preferred method of receiving public input and may be sent by mail or email. You can also provide oral input by joining the hearing in-person or electronically.

All interested persons are invited to attend this meeting to find out more about this application and offer comments. The public meeting is scheduled to take place on Tuesday November 28, 2023 at 4:00 pm, in Committee Room 2 at City Hall for the Committee of Adjustment to consider this application.

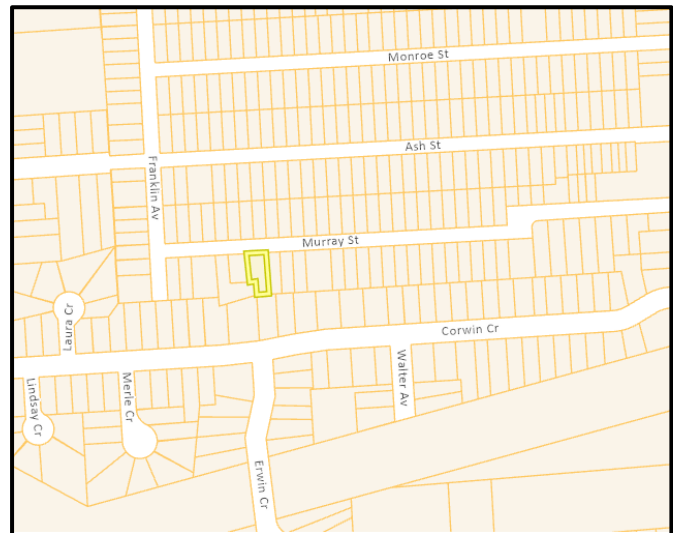

Location: The subject property known as 6494–6496 Murray Street is located on the south side of Murray Street between Franklin Avenue and Drummond Road.

The applicant is requesting the Committee of Adjustment to consider minor variances from provisions of Zoning By-law No 79-200, as amended, through a process permitted by Section 45(1) and a consent under Section 53 of the Planning Act (R.S.O. 1990, c.P.13).

Proposal: The applicant is proposing to sever the subject lands into two parcels (Parts 1 & 2) for two existing semi-detached dwelling units to be sold individually. The subject property is zoned Residential Two (R2-1102), in accordance with Zoning By-law No. 79-200, as amended. The following variances have been requested:



By-law Section	By-law Requirement	Proposed	Extent of variance
Minimum rear yard depth	7.5 metres	6.79 metres (Part 1)	0.71 metres

If a specified person or public body that files an appeal of a decision of the Committee of Adjustment for the City of Niagara Falls in respect of the proposed minor variance does not make written submissions to the Committee before it gives or refuses approval, the Ontario Land Tribunal may dismiss the appeal.
