

**Location:** The subject property known as 5683-5705 Church's Lane is located on the north side of Church's Lane between Gail Avenue and Henley Avenue.

The applicant is requesting the Committee of Adjustment to consider minor variances from provisions of Zoning By-law No 79-200, as amended, through a process permitted by Section 45(1) and a consent under Section 53 of the Planning Act (R.S.O. 1990, c.P.13).

**Proposal:** The applicant is proposing to sever the subject lands into four parcels (Parts 1-4 inclusive) for four existing townhouse dwelling units to be sold individually. Part 5 will be dedicated to the City of



Niagara Falls for a road widening. The subject property is zoned Residential Mixed Zone (R3-1062) Zone in accordance with Zoning By-law No. 79-200, as amended by By-law No.2018-067. The following variances have been requested:


