The City of Niagara Falls is creating a new Official Plan - a roadmap that will guide the City through a period of unprecedented growth to the year 2051, while providing a high quality of living experience for both our residents and visitors from around the world.

TAKE NOTICE that The City of Niagara Falls invites all interested persons to attend a Special Meeting of Council for the purpose of informing about the initiation of a new Official Plan for the City of Niagara Falls. Public input is being sought at the initiation of the project to inform Council and the Project Team of community priorities that should be considered through the development of the new Official Plan.

#### WHAT IS AN OFFICIAL PLAN?

An Official Plan is a document that guides and shapes the future of a community by identifying where, and under what circumstances, specific types of land uses can be located within the City's Municipal Boundary. An Official Plan applies to all lands within the Municipal Boundary.

It is the purpose of an Official Plan to focus new growth in a way that makes efficient use of land and infrastructure, creates attractive and livable communities with a variety of housing options, and protects the City's cultural and natural heritage and agricultural lands.

#### WHY DO WE NEED A NEW OFFICIAL PLAN?

The City's current Official Plan was approved by the Minister of Municipal Affairs on October 6, 1993. The document is outdated and has been amended over 160 times. The City's Official Plan must also be brought into conformance with the new Region of Niagara Official Plan that was approved by the Province in November 2022.

A new Official Plan will apply a fresh approach to the City's land use policies and mapping, ensure conformity with new upper all tier documents and introduce new policies related the important issues facing the City such housing and employment targets, the provision of a spectrum of housing types, preparation for a changing climate, the protection of our resources and more.

The City will be engaging a Professional Planning Consultant in early 2024 to lead the project with a full program of community engagement and gathering public input, and updating legislative requirements to create a new planning approach in a user friendly document.



### YOUR FEEDBACK IS IMPORTANT

This Official Plan affects everyone who lives, works in or visits Niagara Falls. This Public Meeting, as required by the Ontario Planning Act, is an opportunity for you to participate as we develop a vision for the Official Plan. Your input is important to us, as an early guide to community priorities for the City's future. There will be ongoing opportunities throughout the preparation of the new Official Plan, over the next year, for continued participation and public input.
