#### 4 New Business

a. Volunteer Recognition Evening – 2020;

Beth advised that the sub-committee met on zoom in the summer and decided to alter the event. # c. Recreation & Culture updates.

- i. Beth announced that the Pickleball courts are complete at John N. Allan Park and a small opening will be held at the park on Monday, September 28<sup>th</sup>. It was noted that the park looks great with all the improvements.
- ii. Kathy advised that the Recreation, Culture and Parks Master Plan is moving forward. The Consulting firm of Monteith Brown has been awarded the contract and they are well experienced. The launch will take place at the Farmers Market.
- iii. The Millennium Recreational Trail Rotary Storywalk Pathway (Section5)

Beth advised that the new section of the Millennium Trail is now open. The trail has an additional 1.2 km of trail space which is between Dorchester Road and Drummond Road, connecting to other sections of the Millennium Recreational Trail.

She also advised that the 14 Storywalk boards will be installed through this section in the Spring of 2021 and a grand opening event will take place at that time.

## iv. Operation Awesome Playgrounds

Beth advised that the following 10 playgrounds will be upgraded and once they are completed the City will have completed 40 playgrounds in 4 years.

Coronation Park - 5775 Hanan Avenue

Preakness Park (turf safety surfacing only) - 7857 Preakness Street
Oakes Park
Warren Woods Park East (7865 Hackberry Trail) - new park and playground
Warren Woods Park West (8707 Warren Woods Avenue) - new park and playground

- v. Beth advised that the construction of the Culture Hub (Niagara Falls Exchange) will begin soon. Approximate completion date is May 2022.
- vi. Kathy Moldenhauer updated the Committee on the opening to the public of Recreation facility buildings.
