### **Financial Assistance for Provincial, National, International Competitions**

- 1 The Recreation Committee will annually include funds in their budget to assist teams or individuals to participate in recreation type competitions at a Provincial, national or International level.
  
- 2 Financial Assistance may be provided if an application meets the following conditions:
  - a. An official grant application form is completed and submitted prior to the competition.
  - b. Application must be a student, minor, senior or handicapped.
  - c. Participation in the competition must have resulted from a culmination of sanctioned competitions at a local, regional or provincial level. Participation in an invitational type competition, which does not require satisfying a specific level of achievement, is not eligible for funding.
  - d. Applicant shall indicate the governing body involved in the event and provide proof that they have competed successfully at sanctioned competitions.
  - e. Participant must be of an amateur status in the competition.
  - f. All successful applicants must produce a financial statement of revenue and expenditures following the competition of their event with details of daily expenses and copies of receipts.
  - g. Funding under this category will be granted only to defray the participant's cost of competing.
  - h. Applicant shall advise of any financial assistance received from the governing body or any other source.
  
- 3 Approval of request may be subject to any further conditions that the Recreation Committee may see fit to establish.
  
- 4 Grants will be limited to one per year per applicant.
