**Please note the following Revisions to Specifications – Pg. 3 – Equipment Section**

- 1. Trailer Hitch HD with pintle type removed.**
  - a) Replacement must have a rear trailer hitch plate capable of handling the maximum trailer towing capacity of the truck.**
  - b) The hitch plate is to come with two (2) safety chain eyes that will be appropriate for handling the maximum trailer towing capacity of the truck.**
  - c) Must come with a 7 wire RV style plug mounted in place with cover.**
  - d) The hitch to be a Holland PH-30RP41 pintle hook.**
- 2. Truck to be equipped with 2 front recovery tow hooks.**

**Please note the following Revisions to Specifications – Pg. 4-5 – Dump Body Section**

- 1. 2 LED Star beacon lights removed.**
  - a) Add Unit to be equipped with 2 – 16 inch LED mini light bars SWS Part #16310, one on the left side and one on the right side permanently mounted.**
